## **RIGHTS ISSUE - EXTENSION OF CLOSING DATE**

Global Oil & Gas Limited (“**GLV**” or “the **Company**”) (ASX: GLV) advises that the closing date for its Rights Issue has been extended to 5.00pm (AWST) on Monday 21 September 2020 from the previous closing date of Thursday 17 September 2020.

### **Application details**

Eligible shareholders wishing to participate in the Rights Issue should apply by completing the original Application Form mailed or emailed to them and returning it to the address as indicated on the Application Form together with the appropriate payment for the number of shares applied for under the Rights Issue or by making payment directly by Bpay.

Eligible shareholders can also access their Application Form electronically on the Advanced share registry website at <https://www.advancedshare.com.au/Investor-Login> using their investor login. You will need your HIN (with prefix X) or SRN (prefix I). Your entitlement form is found under ‘document print’ and by clicking on ‘Corporate Action Form’. You can then download and print your form by clicking on the relevant green link.

### **Application Entitlement**

Under the Rights Issue, each eligible shareholder is entitled to apply for one New Share in the Company for every three existing shares held at Record Date without incurring brokerage or other costs. The issue price of New Shares under the Rights Issue is \$0.007 per share. Subscribers under the Rights Issue will also receive 1 free attaching new option for every three New Shares subscribed for and issued (exercisable at \$0.02 on or before 15 December 2022).

### **Application Closing Date**

Applications and payment must now be received by 5pm (AWST) on Monday 14 September 2020. The issue date for New Shares subscribed for under the Rights Issue will be now 28 September 2020 with quotation of new shares and despatch of holding statements expected to take place around September 29 2020.
